

About the Lecturer



Heidi Mandanis Schooner

Professor of Law The Catholic University of America Columbus School of Law

Heidi Mandanis Schooner is a professor of law at Columbus School of Law, The Catholic University of America. She has extensive experience as a practitioner and scholar in the regulation of the financial services industry. As a practicing lawyer, Professor Schooner served as in-house counsel to a Washington, D.C., area bank holding company, and in the General Counsel's Office of the Securities and Exchange Commission.

Professor Schooner's scholarship addresses a wide variety of topics relevant to the financial services industry. She has studied the liability of bank directors, the institutional structure of regulatory agencies, and the international regulation of bank capital. Recently, Professor Schooner co-authored an article examining the patent activities of large financial institutions, "Big Banks and Business Methods Patents," 16 *University of Pennsylvania Journal of Business Law* 431 (2014) (with Megan La Belle). Professor Schooner also co-authored a book on international bank regulation, *Global Bank Regulation: Principles and Policies* (Elsevier 2010) (with Michael W. Taylor).

Professor Schooner's Foulston Siefkin Lecture at Washburn University School of Law will focus on the regulation of banks' capital. The regulation of bank capital has been a particular focus among policymakers since the 2008 financial crisis. Professor Schooner will explore the challenges in regulating banks' capital and, in particular, the role of bank management in determining the level of capital that allows a bank to operate efficiently and, at the same time, consistently with principles of safety and soundness.

The *Washburn Law Journal* has been Washburn University School of Law's flagship publication since 1960. The *Journal* is edited by a board of seven Senior Editors and typically has a membership of thirty-five students per year. Membership is based on a combination of law school grades and writing competitions. On average, the *Washburn Law Journal* publishes between eight and fourteen student Notes and Comments written by its members in each volume. Each year, from three to six students present their work in a scholarly forum that is well-attended and generates lively discussion.

The *Washburn Law Journal* produces three issues a year, which make up one volume. One issue traditionally takes the theme of the annual Foulston Siefkin Lecture, which since 1978 has been sponsored by the Wichita-based firm of Foulston Siefkin LLP. A second issue usually falls under the Board of Editors' creative control; and the third issue takes the theme of the Law School's annual symposium, which is co-sponsored by the *Journal*. The *Journal* is often cited by the Kansas Supreme Court and Court of Appeals, as well as by numerous other scholarly publications.
